

## **Indicators of Child Sexual Exploitation Aide Memoire**

## How to use this guide

The guide should be used alongside the Buckinghamshire Safeguarding Children's Board (BSCB) CSE (Child Sexual Exploitation) Policy: <a href="Bucks-Iscb CSE">Bucks-Iscb CSE</a> Practice Guidance 2014.pdf to support preliminary assessment of children aged up to 18 (or 25 with a learning difficulty) when a professional has concerns that a child may be at risk of, or is a victim of sexual exploitation. This is for guidance only and is not a definitive determinant of risk. Professionals are encouraged to use their own instincts and judgement to reach a decision to refer. It is recognised that individual professionals hold valuable information about children and the risk(s) to which they are exposed. It is important to share this information to ensure that statutory agencies are able to fulfil their safeguarding responsibilities.

If appropriate within the context of the working relationship between the child and the professional, it is recommended that the child is involved as much as possible in the screening process.

	Repeated sexually transmitted infection(s), has had one or more pregnancies or terminations and repeated request(s) for the 'morning after pill' Spends time with other children who have reputation for multiple sexual partners Gets into unknown adults or peers cars Has pattern of street homelessness or frequent missing/absent episodes (reported or not) Has older boyfriend/girlfriend Parents/carers don't report missing episodes Returning from missing episodes drunk, drugged or dishevelled Drug and alcohol use with adults/significantly older young people Disclosure of physical or sexual assault Physical injuries internal/external consistent with physical coercion Unaccounted for cash, alcohol, drugs, cigarettes, clothes, mobile top-ups Is sending physically revealing pictures via social media Regular, frequent abuse of substances/drug dependent Has multiple mobile phone numbers or frequently changes phone number/SIM card

	Has contracted a sexually transmitted infection (STI), has had a pregnancy/miscarriage/

	Deterioration in, or low interest and achievement in school work
	Series of fixed term exclusions/internal exclusions

Unwillingness/inability to comply with school rules, discipline and order
Bullied and/or bullying
'Looked After Child' with repeated failed placement breakdowns
Domestic Abuse within young person's own relationship with 'boyfriend' or 'girlfriend'
Blurred sexual boundaries within the home and/or sex offenders within family
Meets adults/unknown peers on the internet, phone apps or out in public places
Frequently staying out late/overnight without permission
Parent/carer failing to report young person missing
Persistently running out/off from home/placement
Experimenting with alcohol/drugs
Associating with unknown adults and/or sexually exploited children
Excessive secrecy around social movements/friendships
Having access to premises not known to parent/carer
Limited/reduced contact with family/friends
Poor self-image/self esteem
Internal expression of despair: Cutting, overdosing, eating disorder
External expression of despair: Bullying, violent outbursts, offending.
Inerabilities – five or more are present in combination with two or more medium risk factors; l/or one high risk factor – contact Children's Social Care/Police
